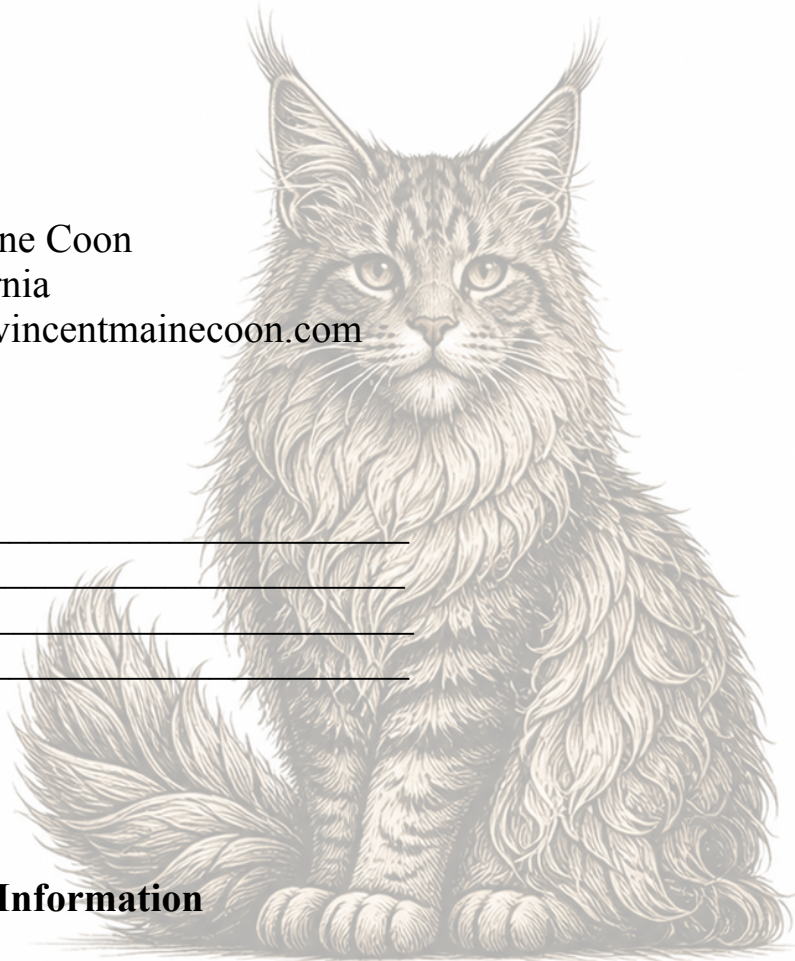

- The kitten will not be neglected, abused, or resold

 **5. Health Guarantee**

The Seller guarantees that:

- The kitten is in good health at the time of transfer
- The kitten has received age-appropriate vaccinations and care

Buyer responsibilities:

- The Buyer must have the kitten examined by a licensed veterinarian within **72 hours**

If a serious health issue is identified within 72 hours:

- Buyer must provide written documentation from a licensed veterinarian
- Seller may offer:
  - Replacement kitten, or
  - Partial refund (at seller's discretion)

 **6. No Guarantee**

The Seller does NOT guarantee:

- Future size, temperament, or color changes
- Compatibility with other pets
- Show or breeding potential unless explicitly agreed in writing

 **7. Spay/Neuter Agreement**

Unless otherwise agreed:

- The kitten is sold as a **pet only**
- Buyer agrees to spay/neuter the kitten by appropriate age

 **8. Return Policy**

If the Buyer is unable to keep the kitten:

- The Seller must be notified
- The kitten may NOT be surrendered to shelters
- Seller has the **right of first refusal**

No refunds will be issued after pickup.

 **9. Media & Updates**

The Buyer agrees that:

- Seller may use photos of the kitten for website/social media
- Buyer is encouraged (not required) to provide updates

 **10. Liability**

After the kitten leaves the Seller:

- The Seller is not responsible for any future health or behavior issues
